## Session paper submission

- A Special session must include a minimum of 5 papers.
- All papers for the special session will be submitted directly to the organiser. No special session papers are to be submitted through the i-Society 2006 website.

- Session paper review (each paper should be reviewed by at least two independent reviewers)
- Final selection of papers for the session;
- Notification of paper acceptance/rejection and sending review comments to authors;
