Time commitment: Approximately 5-10 hours per month split between all blog editors.

Deputy Blog Editor

The Deputy Blog Editor is committed to the following:

Working with the Blog Manager to ensure that blog posts happen on a regular basis at approximately 1 post per month.

Working with the Blog Manager to ensure consistency in the entire blog posting process.

This includes:

solicitation and management of posts

identifying potential authors,

soliciting content, editing, signing of authorship agreement, posting and communications associated with the dissemination of the blog post.

Time commitment: Approximately 5-10 hours per month split between all blog editors.

The Committee meets face-to-face once a year (usually at the annual conference) and virtually about three times a year, to move forward with the group's work. Committee terms are usually for two years, with the possibility of extension for a further term.
